Zahira Aragüete-Toribio, Post-doctoral Researcher in Law, Université de Genève, Geneva

Her research in visual anthropology focuses on the role human remains, documents, oral accounts and expertise play in the construction of new histories and political claims about the past.

Jean-Louis Arcand, Professor and Head of the International Economics department, IHEID, Geneva

His research deals with the microeconomics of development. He conducts impact evaluation research in Sub-Saharan Africa and Maghreb. He also did consulting for numerous NGOs, IOs, and governments.

Lucia Direnberger, Research coordinator for the DEMETER project, IHEID, Geneva

Her research focuses on interactions between globalization, gender, nation, and nationalism. Her areas of interest include Iran and Central Asia. She is also the coordinator of IHEID's Gender Centre's advanced studies certificate in gender and development.

He is currently working on the articulations between sex, class, and race within both the French and the British music industries. He is also interested in careers and collaboration between cinema and music industries.
