Field-work and focal points of my research – My research was conducted during my Master in Psychology (Turin, 1996), my PhD in Anthropological Sciences (Turin, 2005), and during the Postgraduate School in Psychoanalytic Training (Laboratorio Freudiano - Milan, 2009). I have been Researcher and Assistant Professor since 2007, and member of the Research Team of several Ethnographic Missions in West and Sub-Saharan Africa. Main focus of my research is medical and psychological anthropology: 1. Migration, Health, and Violence (particularly Nigerian Diaspora); 2. the Transformations of Health System in Sub-Saharan Africa (my fieldwork was in Cameroon, Mali, Uganda and Mozambique); 3. Migrant and Refugee families and the politics of childhood (Italy).

At the moment I am researcher in two Teams: Ethnographic Missions in Sub-Saharan Africa (University of Turin, Italy) and “Integra” Project (University of Eduardo Mondlane, Centro de Estudos Africanos, Maputo, Mozambique).

Major Grants (2014-2015 – 2019-2020) – I have won two European Projects (F.E.I – European Integration Funds – Ministry of Interior) as Principal Investigator for the integration of immigrant population in host country: “The reverse of migration. A comparative analysis of protection and health rights” (University of Turin, April, 1 2014-June, 30 2015, Fund: € 174,839.60); and “S.p.a.c.e.s. Between. Services for the social, educational and clinician treatment” (Frantz Fanon Association, April 8 2014-June 30 2014, Fund: € 168,593.55). I had coordinated two Teams with several researchers and professionals involved.

In 2014-2015 I was also Principal Investigator of the Project “Contested Childhood: Children and the Politics of Culture”. I have coordinated a Research Team of 4 researchers (2 Post-Doc and 2 Phd students) involved in various fieldwork (Togo, Ecuador, Colombia and Italy).

In 2019 I have won as Scientific Coordinator one project for the social inclusion and support of refugee and international students, financed by the Ministry of University and Research (Passi@unito) with € 50,000 for the first year. The project is still ongoing, and I coordinate a Research Team of 4 researchers (scholarships for Phd students with a competence in social science, linguistic, psychology and anthropology).

Didactic work at University – From 2014 till now, I have been Professor of Anthropology of Childhood (36 hours) at the Department of Cultures, Politics and Society for Graduate students in Anthropology, Psychology, Social Science; and I coordinate the Lab on Critical Anthropology of Migrations (18 hours) for Graduate students of the same disciplines. I also teach Introduction to Cultural Anthropology for Undergraduate students in Social Science at the same Department (72 hours per year)).

From 2007 to 2013, I was Professor of Anthropology at the Faculty of Psychology of Turin (now Department of Psychology) for Undergraduate Students (Bachelor Degree in Science and Psychological Techniques), University of Turin: 64 hours each year.

In 2011-2012, I was Professor of Psychological Anthropology at the Faculty of Philosophy, for Graduate Students (Master in Anthropology and Ethnology), University of Turin: 36 hours. From 2008 to 2010, I was Professor of Ethnopsychology and Ethnography at the Faculty of Psychology of Turin, for Graduate Students (Master in Sciences and Techniques for Development and Evolutional Age, University of Turin: 64 hours each years). From 2008 to 2011 I was a Lecturer in the Postgraduate Course in Medical Anthropology at the University of Milan (Bicocca), and in several PhD Courses at the Universities of Turin, Siena and Rome.
