RESEARCH

I have been involved over the past 20 years in longitudinal research examining the gendered and generational displacement and emplacement of South Sudanese Nuer population. My work first focused on livelihood strategies access to rights of urban refugees and asylum seekers in Cairo, Egypt. This research was supervised by Prof. Barbara Harrell-Bond.

For my doctoral research, I carried out fieldwork in refugee camps in Kenya and then followed displaced populations returning to South Sudan. I examined gendered and generational impacts of war and displacement and gendered and generational strategies of emplacement in the context of refugee return. This research was supervised by Prof. Ann Whitehead and Dr. Lyla Mehta.

In my post-doctoral research, under the NCCR North-South in Switzerland, I examined gendered meaning of migration and regional migration policies in Ghana, Kyrgyzstan and Nepal. The work supervised by Dr. Susan Thieme and Dr. Esther Schelling.

My current research involves two strands of work. One is a continuation of the previous research among Nuer South Sudanese newly displaced to Khartoum in Sudan. This is part of a larger CEDEJ Khartoum funded project that analysis the urban changes in Khartoum as a result of the separation of Sudan, and the social, political, economic and identity inbetweeness in has created among different urban populations. The second strand of current research examines the links between migration of adolescent girls in the Global South and their transitions into adulthood through a holistic approach that contextualised adolescents’ agency, choices and migration experiences. Currently, I am involved in two research projects: collaborative knowledge production through examining Eritrean refugee organisations hosting refugees in Geneva; and studying creative practice (music and dance), mobilities and citizenship issues in Laos and Sudan. In my current project with PRIO, I am researching art, artists and social transformations in the context of war and political conflicts.

I have published widely and presented the results at various conferences, seminars and invited lectures. I have also co-produced documentary films that allowed for a wider dissemination of the research findings. By involving research participants in the fieldwork, analysis and documentary making, I ensure co-production of knowledge. I have used a wide range of research methods, including ethnography, photography and film, collection of quantitative data, analysis of documents, surveys, expert interviews, and life stories. The last film, *2 Girls*, based on research among adolescent girls' migrants in Ethiopia and Bangladesh, received over 10 first prize awards for best documentary at international festivals in including those in Warsaw, Rome, and Tiburon, and has been screened worldwide. My most recent film (2018), *Barbara Harrell-Bond: a life not ordinary*, is focused around a life story of Barbara Harrell-Bond, a social anthropologist, researcher, advocate for refugee rights, and a founder of Refugee Studies Centre at the Oxford University, as well as several other refugee studies centres around the world and legal aid organisations for refugees.
