#### **RESEARCH ACTIVITIES**

Research interests include: the social and political <u>determinants of health in conflict</u>, attacks on healthcare and impact of <u>human rights violations on health</u>. I developed the concept of the weaponization of healthcare - using people's need for healthcare as a weapon against them as a force multiplier of war crimes, driver of displacement and infectious diseases the manipulation of chlorine, our primary tool of public health, into a chemical weapon, and means of passive biological warfare. This includes the drivers of global infectious threats (polio, TB, Ebola) in conflict zones and settings of chronic insecurity, and of antimicrobial resistance including superbugs such as A. baumanii, MDR and XDR TB.

<u>Trained immunity</u> - the off-target beneficial effects of live vaccines a longstanding area of focus. In January 2020 I urged WHO to support research into the off-target effects of BCG, measles and other live vaccines as bridging vaccines for pandemic threats and to reduce the impact of Covid19. After development of concept with Prof Curtis in Melbourne and Prof Netea in Utrecht, the BRACE Randomised Controlled Trial was initiated in April 2020 involving 4000 Healthcare workers (HCW) in Australia. After expanded interest helped by a <u>Lancet publication with the Director-General</u>, the trial was funded by the <u>Bill and Melinda Gates Foundation</u> (\$10Million), extended to the Netherlands, the US and South Africa and enrolled at least 10,000 HCW.
