- Regular virtual meetings every 2 months Committee and Alumni Office

Engagement des anciens

La communauté compte désormais près de 22'000 membres, 4'800 d'entre eux sont connectés sur LinkedIn. Bourses et prix

The **Alumni Community Scholarship** was established in 2013 to fund the academic and living expenses of a student in financial need for a year. Funds for the scholarship are collected through direct donations on the Alumni Scholarship webpage and also during a raffle and silent auction held at the annual Alumni Reunion, which reunites alumni from around the world each year. This year, the scholarship goes to

Gloria Efua Nkrumah completed her BA in Sociology at the University of Cape Coast (Ghana). She then worked as a Teaching and Research Assistant in the Department of Sociology and Anthropology, and served as a Peer Facilitator for the Centre for Gender

Research, Advocacy and Documentation at the same institution. She is now pursuing a master's degree in Anthropology and Sociology at the Institute, with her thesis focusing on help-seeking behaviours of victims of gendered violence. Through her work, she aims to improve access to healthcare, education and social services for marginalised communities, particularly empowering young girls and providing support systems for victims of gendered violence. Ultimately, Gloria hopes to run for president someday.

"Thanks to the scholarship awarded to me by the Alumnae-i community, I am now in Geneva, where I can envision a society with easy access to quality health care and free of gendered violence. I eagerly look forward to the day when I can also help other students fulfil their dreams."

The 19th AAID prize (CHF2,000) for the best doctoral thesis is awarded this year to

Rohit Ticku, Research Fellow at the Robert Schuman Centre for Advanced Studies, European University Institute for his thesis in development economics entitled *Empirical Essays on Conflict and Corruption* co-directed by Nicolas Berman et Lore Vandewalle.

Abstract: Social conflict and corruption are arguably the two most significant challenges to economic development. Rohit Ticku's doctoral research studies the processes leading to these detrimental outcomes to derive fresh insights for contemporary policy. The dissertation comprises of four papers that combine innovative data collection and causal inference strategies to study problems of conflict and corruption:

- Economic Shocks and Religious Conflict in Medieval India
- Riot Rewards? Religious Conflict and Electoral Outcomes
- Votes for Sale
- Reducing Tariff Evasion: the Role of Trade Facilitation

Suba Umathevan was born in Kilinochchi, Sri Lanka, in 1982. At the age of two, she fled the war-torn country with her family and arrived in Bern. She holds a Master's degree in International Affairs with a specialization in International Law from the Institute, and an Honours degree in International Studies and Modern Languages from the University of Ottawa. She began her international career as a research fellow at UNESCO-International Bureau of Education, where she assessed mother tongue and bilingual education programmes in Sub-Saharan African countries. Suba has spent nearly a decade in Nonprofit management and has dedicated her work to women's and children's rights. Suba was Programme Executive at Soroptimist International of Europe, where she helped develop Programme and Advocacy of the organization. She led development programmes in a number of countries in Africa, Asia and South America. Her thematic expertise is in women's economic empowerment, education in emergencies, gender-based violence, female genital mutilation/cutting, and early marriage.

Suba spent a few years designing and leading learning programmes for people and strategy development with executives across the globe, identifying global megatrends and preparing leaders to transform.

Suba was the CEO of Plan International Switzerland, an organization that advances children's rights and equality for girls. Before, she joined Plan International Switzerland as the Head of Major Partnerships, developing a clear fundraising strategy and building multifaceted foundation, corporate and institutional partnerships. Plan International Switzerland focuses on delivering high-impact programs to create the conditions for adolescent girls and young adults to be educated, safe and economically empowered in over 75 countries across the world.

Today, Suba is the CEO of DROSOS FOUNDATION. The Foundation supports projects aimed at promoting life skills of disadvantaged children and young people. With offices in Berlin, Cairo, Casablanca, Ramallah, and Zurich, DROSOS FOUNDATION co-creates projects to promote economic independence and creative skills of young people in the MENA region, Switzerland and Germany.

Suba Umathevan is a member of the Assembly of the International Committee of the Red Cross (ICRC).

Mahmud Samandari holds a PhD in International Law from the Institute. He co-founded and presided over the first national alumni chapter of the Institute, in Quito, Ecuador. He is the Secretary General of the Global Governance Forum, as well as founder and Secretary General of ebbf (ethical business building the future). He oversees the international expansion of soul.com in several continents. A serial entrepreneur, he was a pioneer in establishing the first satellite-based interactive distance-learning platform in Latin America in the 90's, built joint ventures, set up PPP projects, and several startups in the fields of IT, telecommunications, public transportation, mobile applications, and education both in Europe and Latin America.

He is a coach and as such collaborated with the startup program of the Swiss government's Commission for Technology and Innovation. A team-builder and alliance-maker he has set up several partnerships with corporations, universities, international organizations and government entities. A firm believer in the nobility of human beings, his passion is to help people and organizations realize their vast and untapped potential. Working with youth is of particular interest to him. For years, he was a mentor and advisor to AIESEC in different countries. As a world citizen, he speaks 5 + languages and has travelled extensively around the world, has lived in 3 continents and has had the pleasure of being exposed to multiple cultures and realities, which he considers a privilege and the best school for life. Married, he has three children and two granddaughters.

Jacqueline Kossiwa Tossoukpe is a global Diversity, Equity, and Inclusion (DE&I) advisor at UBS. She started her career in 2009 as the first black female police officer in Zurich. This experience sparked her drive to specialize in diversity and inclusion policy development and management. During her studies at IHEID, she worked for the Geneva Center of Security Sector Policy (DCAF) and the United Nations Institute for Training and Research (UNITAR) to support policy implementation and train-the-trainer initiatives to advance gender diversity in the police, military, and peacekeeping operations in Sub-Saharan Africa and the Middle East. She followed on to work for the Swiss Embassy in South Africa and the Permanent Delegation of Switzerland to UNESCO as a diplomatic attaché and scientific officer. There she contributed to strengthening Switzerland's foreign policy as well as gender equality strategy.

Jacqueline is also the Founder and former CEO of the diversity-consulting firm Kesecurix, which she started as a blog during her studies in Geneva. From 2017 until 2021 she advised local and international companies on sustainable policies to advance their diversity and inclusion strategy. In her current role at UBS, she provides strategic DE&I advisory for the business functions to execute UBS Global DE&I Strategy. She is also the lead for Switzerland's Race and Ethnicity Inclusion initiatives and is the liaison partner with external diversity business stakeholders.

She was born in Ghana and migrated with her single mother to Zurich in 1990. She holds a master's degree in International Affairs from the Institute and a bachelor's degree in International Criminal Justice from John Jay College of Criminal Justice (CUNY). In her free time, she enjoys travelling, is a fitness enthusiast, and likes reading and watching documentaries.

Matthew Stephenson is Head, Investment Policy and Practice, at the World Economic Forum, where he manages the Global Investment Policy and Practice initiative, including projects in five countries and plans to launch an alliance to Enable Action on Sustainable Investment (EASI). He has developed the concept of Digital FDI and SusTech. Previously he worked at the International Finance Corporation on advisory services for investment policy, where he led the work stream on outward FDI (OFDI), and co-authored the World Bank Group's first publication on OFDI. He has also worked at the OECD on Africa and on investment and was a diplomat with the US Department of State, where he led the economic team on Afghanistan and managed economic programmes in the Middle East.

He is a member of the T20 Task Force on Trade, Investment & Growth and T20 Task Force on Digital Transformation, providing policy proposals to the G20. He is also co-chair of the Investment Facilitation Commentary Group, which advises the WTO, represents the World Economic Forum at APEC's Investment Expert Group, and is part of the U.S. Speaker Program through which the United States sends experts to speak around the world. Matthew has a PhD from the Graduate Institute of International and Development Studies, a master from the Harvard Kennedy School, and a bachelor from the University of Oxford.
